ISSUE STATEMENT

The certified election results for the November 5, 2024 General Election have been received from Lane County Elections.

The results and terms for Mayor and City Councilor are below, and elected officials will be sworn in on January 14, 2025.

Position	Name	Term
Mayor	Ken Wells	2 years
Councilor	Ken Hancock	4 years
Councilor	Sidney Washburne	4 years
Councilor	Kenneth Jamieson	4 years

Mayor Wells and Councilors Hancock and Washburne went through the process to get their names on the ballot and were elected to fill positions. This left a third open City Councilor position, and many write-in votes were received.

Kenneth Jamieson received the most write-in votes for the third City Councilor position. It was determined that he was qualified to serve, and he has completed the necessary paperwork to accept this position.

Per ORS 254.565, certificates of election have been prepared and will be distributed at this meeting.

BACKGROUND

Elections for the Mayor's position and staggered City Councilor positions occur every two years.

The certified elections results include language on overvotes and undervotes. An overvote occurs when an elector marks more than the allowable choices for a particular office or measure. An undervote occurs when the elector casts fewer votes than the allowable choices for a particular office or measure or no selection is made.

RELATED CITY POLICIES

City Charter

SECTION 8: COUNCILORS

The term of office of a Councilor in office when this charter is adopted is the term of office for which the councilor has been elected before adoption of the charter (or is elected at the time of the adoption). At each general election after the adoption, three council positions shall be voted upon, each for a four-year term.

SECTION 9: MAYOR

The term of office of the mayor in office when this charter is adopted continues until the elected successor to the office assumes the office. At each subsequent general election, a mayor shall be elected for a two-year term.

SECTION 10: TERMS OF OFFICE

The term of office of an elective officer who is elected at a general election begins at the first council meeting of the year immediately after the election and continues until the elected successor to the office assumes the office. When there is both a two-year and four-year vacancy to be filled, those candidates receiving the highest number of votes shall fill the vacancies with the longest terms.

Junction City Municipal Code – Chapter 2.65 - CITY ELECTIONS AND CANDIDATE NOMINATIONS

2.65.010 Elections. Except as this chapter or the city charter prescribes to the contrary, a city election shall conform to state statutory provisions governing elections as set forth in ORS Chapters [246](#) through [260](#). [Ord. [1044](#) § 1, 1998.]

2.65.020 Nominations. A candidate for a city office shall be nominated by filing a petition with the city recorder. Such petition shall have been signed by a minimum of 30 registered voters within the city of Junction City, and shall be filed with the city recorder within the time frame established by statutory provisions in JCMC [2.65.010](#). [Ord. [1079](#) § 1, 2000; Ord. [1044](#) § 2, 1998.]
