\$25,001 - \$50,000	\$416.75 for the first \$25,000 and \$1.60 for each additional \$100 or fraction thereof, to and including \$50,000
\$50,000 and up	\$816.75 for the first \$50,000 and \$1.32 for each additional \$100 or fraction thereof

Other inspections and fees:

1. Re-inspection fee - \$68.75 per inspection
2. Each additional inspection - \$68.75 per inspection
3. Inspections for which no fee is specifically indicated - \$68.75 per inspection
4. Plumbing investigation fee - \$77 per hour
5. Additional plan review required by changes, additions or revisions to plans - \$80 per hour
6. Inspections outside of normal business hours - \$103 per hour (minimum charge of 2 hours)
