

Junction City Municipal Court Traffic Deferred Prosecution Program

You may be eligible for the Traffic Deferment if:

1. You have had no other moving violation convictions during the last three years.
2. You have not participated in a traffic deferment program during the last five years.
3. You do not currently hold a commercial driver's license.
[per ORS 153.090 (7)]
4. Your violation did not involve a motor vehicle accident

These are the conditions of the Traffic Deferment:

1. Enter a plea of no contest to the charge you have been cited for.
2. Complete the Deferred Prosecution Agreement / Order of Deferment form.
3. Pay the \$100.00 court cost.
4. Attend and complete a court approved traffic safety course or 55-Alive program. There is an additional fee for the traffic course paid at the time of enrollment.
5. File the certificate of completion for the traffic safety course with the court prior to the end date of the Traffic Deferment program.
6. Receive no further traffic violation convictions during the 4-month deferment period.

If you successfully complete all conditions, your charge will be dismissed at the end of the 4-month period!

The defendant represents to the court as follows:

1. My true name is _____, and I agree to keep the court advised of my mailing address at all times until this case is resolved. (Initial) _____.
2. I wish to plead no contest to the charge of _____. I give up my right to a trial. I affirm that I have not previously participated in a traffic deferment during the last 5 years and have not been convicted of a traffic violation or traffic crime in the last three years. (Initial) _____.
3. I understand that I waive these rights: a) the right to a speedy trial; b) the right to see, hear and face in open court all witnesses called to testify against me; c) the right to use the power and process of the court to compel the production of any evidence, including the attendance of any witnesses, in my favor; d) the right to testify in my behalf; and e) the right to have the City of Junction City establish my guilt based on the preponderance of evidence presented. 4. I understand as I enter into this deferment agreement the terms and conditions will be the following:
(Initial) _____.
 - a. I enter a plea of no contest. (Initial) _____.
 - b. I agree to pay the court costs of \$100.00 within sixty days of this petition.
 - c. I agree to enroll and complete the court approved traffic safety program and provide proof to the court.
 - d. I will commit no new traffic related offenses during this deferment agreement.
 - e. I will report to the court compliance or non-compliance.
 - f. I understand I must complete all conditions within 120 days of the date of this deferment agreement.
 - g. I agree to pay all fines, fees, and assessments to the court upon my failure of any or all of my terms and conditions of this agreement.
5. I understand and agree that my plea of no contest will be held in abeyance for four months. If, at the end of this period of time, I have successfully fulfilled all the terms and conditions set forth in paragraph 4, my no contest plea will be withdrawn and this charge dismissed. However, if I fail to complete any of the terms and conditions set forth in paragraph 4, the deferment will be revoked, the deferment fee forfeited and the Court will impose a monetary fine plus any unpaid court costs. The violation will be reported to the Oregon Department of Motor Vehicles. (Initial) _____.
